SUMMARY

I conduct research in the field of digital innovation, specialised in the expansion of the **collaborative** economy and digital commons in connection to disruptive technologies (blockchain and artificial intelligence), as well as its public policy implications.

Since 2016 I hold a Ramon y Cajal at the IN3 UOC. I am the leading scientist of the research group Dimmons at IN3 UOC (recognised by the Catalan government 2017 SGR 1590). Since 2013, I have been faculty affiliated at the Berkman centre for Internet and Society (Harvard University).

I have extensive experience leading competitive research. During the last 5 years, I have been the principal investigator of partner members of **three European projects of ICT H2020 call**, two competitive Spanish and Catalan research projects, and two major contracts with the administration. Over my career, I fundraised a means of almost **300.000 euros a year**. In total, I have won **16 highly competitive calls**: 5 european, 3 national, 3 regional, and 3 university internal, and 2 major contracts. **Total jobs created** by the projects I have directed include **5 postdocs** (of 2 to 3 years), **5 predocs** (4 years) and 9 research assistants (diverse durations).

I have published **25 peer-reviewed articles** in Journals (including Q1 such as *Social Movement Studies, Journal Information, Communication and Society, and PLOS ONE*, and three articles at the most prestigious peer-reviewed repository in Computer Science ACM). I have published **46 book chapters** (in editorials including peer-reviewed editorials such as Routledge, Oxford University Press, and IGI Global). I am also the author of 9 books and 6 e-books. I have presented at the ECPR, at The National Bureau of Economic Research (Cambridge, MA), Opensym, and Internet, Politics, & Policy (Oxford).

I have supervised two Marie Skłodowska-Curie postdocs, directing or supervising ten PhD theses (four defended), and one Master thesis at UAB and UOC.

Previously, I was a Juan de la Cierva postdoc at the UAB, and Marie Sklodowska-Curie/Beatriu de Pinos postdoc at the Berkman Klein Center (Harvard), a one year fellow at the Real Colegio Complutense (Harvard) and visiting scholar at MIT. I obtained my PhD in Social and Political Science at the European University Institute (EUI) in 2010, and was a visiting research scholar at Berkeley University and Stanford University in 2008. I hold a Graduate Degree in Economics (U. of Valencia) and in Social and Cultural Anthropology (U. Rovira i Virgili).

My investigation has informed technological development adopted by the APACHE Foundation. My

publications have informed the European Agenda of Collaborative Economy of the European Commission 2016, and I have been advising the Amsterdam, NYC and Barcelona city councils. I am the co-director with responsibility for the program of the Sharing Cities Summit 2018, a major encounter between 40 cities worldwide on sharing economy policies.

Notwithstanding two career breaks, and just seven years after finishing my PhD, I have extensive leadership and independent experience in innovative fields through being the principal investigator for highly competitive European research projects. I am and have been the PI or a partner member of three projects funded by the ICT calls H2020 and FP7 (see table on grants for details). I have been on the advisory board of two other European projects and a ERC Starting Grant Project in the fields of collaborative economy, digital social innovation and digital commons. I led research on the P2Pvalue FP7 European project judged to be Excellent by the relevant EC reviewers, and whose results have been transferred to SMEs and were the basis for the H2020 FoTRRIS and DECODE projects. I have built and led multidisciplinary teams for projects from Spanish and Catalan Research programme, and two major contracts with the local administration. My

My projects have been conducted through two research groups that I myself created and led in two innovative areas of research: Dimmons at IN3-UOC, on the commons and the sharing economy, and the IGOPnet research group at IGOP-UAB on public policies and the Internet. I also co-coordinated the Cooperation group at Berkman Klein Center (Harvard University), a leading worldwide group of collaborative producers at a top global institution for Internet studies.

HIGHEST INTERNATIONAL MOBILITY AND INTERNATIONAL NETWORK CAPACITY

I have extensive international mobility and training in excellence. I have developed pre-doc or postdoc research at leading Universities including Harvard, MIT, Stanford, Berkeley and EUI. I gained the most competitive research and mobility grants in the Spanish Research Systems: Juan de la Cierva, Ramón y Cajal (I was first in the Spanish ranking) and the European system (Marie Skłodowska-Curie). My three affiliations and my three letters of interest reflect on my capacity to gain recognition for my work and excellent working relationships, as well as to build international networks in the centres where I contribute my research and vision.

MULTIDISCIPLINARY PROFILE AND IMPACT

My multidisciplinary capacity is recognised by membership in three prestigious interdisciplinary centres (Berkman-Harvard, IGOP-UAB, and IN3-UOC). I am an economist, an anthropologist and a socio-political scientist, and experienced in Computational Social Science. I have published in journals of these four disciplinary areas. I also have technological experience (between my undergraduate and postgraduate education, I worked for four years as a professional coordinator of technological development projects).

PUBLIC RECOGNITION AND ENGAGEMENT

In recognition of my early career development, I was a finalist in the first round (2013) of the **Elinor Ostrom Award** for Young Scholars in the field of commons theory, only two years after concluding my PhD.

I gained an important profile, impact and visibility at different levels. Regarding policy impact, I have been consulted and engaged by diverse European Union institutions regarding the European Collaborative Agenda (DG Growth, DG Connect, Joint Research Centre, Committee of Regions), and City administrations on collaborative policies (including Barcelona, Madrid, Amsterdam, Seoul and Milan, among others). I am the main organiser of a worldwide major cities summit this year on the policies of the sharing economy, with representatives from 40 cities across all continents, 12 of them which are vice-mayors of economic affairs. Regarding civic society impact, I am a member of the advocacy board of the Open Knowledge Foundation, and on the research committee of the Wikimedia Foundation, both leading institutions in the digital field. Additionally, I have been an investigator with the Transnational Institute and Transform! Europe, both international networks tackling questions linked to political innovation. Regarding industry impact, I have investigated for/with Telecom France, Telefonica, Yahoo!, Telefonica, Microsoft, and I have been a Google Fellow. I presented at the *Mobile World Congress* in 2016 and *Smart City World Expo Congress* in 2016 - 2017 - 2018, both of which are leading global technology industry events. Regarding media impact, I have been referred to and published in Spanish Newspapers (*El País, El Diario, La Vanguardia, El Periodico*) and in international specialist magazines such as *Wise*, and *Shareable*. Finally, regarding digital presence, Wikipedia has a profile page dedicated to my work available in English, Catalan, Spanish and Italian. I am the second person after Wikipedia founder (Jimmy Wales) to appear on the Wikipedia annual fundraiser banner.

PUBLICATIONS AND CONFERENCES PARTICIPATION

My research falls in the broad area of digital innovation, especially on the economic features and conditions for socio economic innovation around collaborative economy, and the public policies associated to its regulation and promotion (See my research statement for more details on main research lines).

My publications reflect the multidisciplinary character of my research interest and work, and my capacity to generate significant academic impact, spanning diverse disciplinary fields. I have published in top journals, given papers and presented at top academic conferences on the diverse disciplinary fields of my expertise (see any of the publications with my supervisor della Porta): **Political Science** (articles at *Policy and Internet, the Journal of Information Technology and Politics* associated with the American Political Science Association (APSA), and given papers and led ECPR-related events on the *Internet, Politics, & Policy conference* (Oxford)); **Social movements** (*Social Movement Studies*); **Computer Science** (*PLoS ONE*, and *ACM*); **Internet/Communication Science** (*Journal Information, Communication and Society (iCS*), and at *OpenSym proceedings*); **Economics** (*MIS Quarterly,* and presented at most world-wide prestigious venues for economic studies *The National Bureau of Economic Research* (*NBER*) *Cambridge, MA*). In addition, I have presented in most of the relevant events emerging on the new field of **collaborative economy studies** (such as Sharing Economy Workshop Winchester 2016 and Lund 2017, Society for the Advancement of Socio-Economics - SASE (Lyon, June 2017), and Sharing Cities Shaping Cities event, Milan 2018)

Altogether, since the beginning of my academic career, I have produced more than 182 academic publications and academic presentations (excluding research reports) (129 since thesis defense 2010), and published 25 peer-reviewed. I have also published 46 **peer-reviewed book chapters** with publishers including **Routledge**, **Oxford University Press** and **IGI Global**. I have a forthcoming **monograph with MIT**. Furthermore, I am the author of nine books and six e-books. I have been able to gain **global reach**, having articles and chapters published in ten different languages, and one of my books has been published in English, Italian and Spanish: Fuster Morell, M. Wainwright, H. & Berlinguer, M. (2007). *Networked Politics*. Rome: XL Edizioni.

100% of my publications are in open access through publishing in open access journals or making them available in open repositories.
